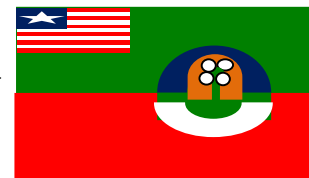

## **Invitation for Bids (IFB)**

*Procurement of Earth Moving Equipment and Dump Truck – Supply and Delivery of Motor Grader, Excavator, Bulldozer, Vibratory Compactor, Wheel Loader, Load Bed & Trailer Head and Dump Truck*

The Margibi County Administration *has received* funds from the Government of Liberia through the County & Social Development Funds and budgetary appropriations toward the cost of procuring five (5) pieces of Earth Moving Equipment, Dump Truck and Tractor Head along with load bed for use by the County during its construction projects. The *Margibi County Administration* now invites sealed bids from eligible and qualified bidders for *the procurement of the below listed items:*

Bidding will be conducted through the International Competitive Bidding (ICB), a procedure specified in the PPCC Act and approved by the Public Procurement and Concessions Commission and is open to all bidders from as defined in the PPCC Act

Interested eligible bidders may obtain further information from *the Procurement Unit, Margibi County Administration* and inspect the Bidding Documents at the address given below *beginning October 13, 2015 between 9:00 AM and 3:00 PM Local Time.*

Qualifications requirements include:

- a. Should be a legally registered business in its country of operations;
- b. Should provide evidence of being tax compliant;
- c. Bidders must have successfully supplied at least two (2) of the equipment within the last two (2) years with value similar to the average cost of the equipment or truck;

Additional details are provided in the Bidding Documents.

A complete set of Bidding Documents in English and Hard Copy may be purchased by interested bidders from the Procurement Unit upon payment of a non-refundable fee of US\$100 (One Hundred United States Dollars). The Bidding Documents can be sent by courier to bidders who make such request. However, additional amount will be charged for said service based on the rate provided by a certified courier firm in Liberia.

Bids must be hand delivered to the address below at or before 13 November 2015 at 12:30 PM Local Time. Electronic bidding *will not* be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address below at 12:30 PM Local Time on 13 November 2015. Bids must be valid for a period of 90 days counting from the deadline for bid submission and must be accompanied by a *Bid Security* in the Amount and Currency indicated above (or an equivalent amount in a freely convertible currency), which shall be *valid for minimum 30 days* beyond the bid validity period *[i.e. 17 January, 2016]*.
